

Assumption of Risk and Waiver of Liability Relating to Coronavirus/COVID -19

The novel coronavirus (“COVID-19”) has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to be spread mainly from person-to-person contact. As a result, federal, state and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Participation in or attending in team formation meetings and/or team retreat for Orlando Cursillo Women’s Weekend # 112 and Men’s Weekend #104 could increase your risk of contracting COVID-19 because an inherent risk of exposure to COVID-19 exists in any public place where people are, or have been, present. I understand that the risk of becoming exposed to or infected by COVID-19 at or during team formation meetings and/or team retreat may result from the actions, omissions or negligence of myself or others.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself (including, but not limited to, personal injury, disability and death), illness, damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with my participation in team formation and/or team retreat for Orlando Cursillo Women’s Weekend #112 and Men’s Weekend #104 (“Claims”). On my behalf, and on behalf of my heirs, I hereby release, covenant not to sue, discharge and hold harmless Orlando Cursillo and its current, former, and future, agents, directors, employees, volunteers, representatives and related entities of and from claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of Orlando Cursillo, its agent, directors, employees, volunteers, representative, whether a COVID-19 infection occurs before, during, or after participation in team formation meetings and/or team retreat for Orlando Cursillo Women’s Weekend #112 and Men’s Weekend #104.

I acknowledge that I have been provided and have read the above paragraphs and have not relied upon any representation of Orlando Cursillo or its current, former, and future, agents, directors, employees, volunteers, representatives and related entities, and that I am fully advised of the potential dangers of participating in team formation and/or team retreat for Orlando Cursillo Women’s Weekend #112 and Men’s Weekend #104 and the transmission of COVID-19.
